SECTION 6 – LIFE MEMBERSHIP – Any Regular member who, at the time of his application for this classification shall have been a member in good standing of the Institute continuously for at least **TEN 10 YEARS** shall be classified as Life Member after verification and approval of his application by the National Board of Directors. Life membership shall thereafter become effective only upon payment of the Life Membership fee prescribed under Section 3 of Article VIII of these By-Laws. A Life Member shall continue to possess and enjoy all the rights and privileges of a Regular Member in good standing but shall already be exempt from the payment of annual dues **AND SHALL ATTEND EITHER THE REGIONAL CONFERENCES, MID-YEAR OR ANNUAL CONVENTION AT LEAST ONCE A YEAR.** He shall, however, still be required to pay all special assessments levied against the active members, the non-payment of which may result in temporary curtailment of his privileges to vote or to be voted upon.
